All women of the Great Mason City USBC Association are eligible to participate.

Entering Averages: Entrants shall use their highest average in one league at the end of the previous winter season schedule for at least 21 games.

If an entrant has no previous winter season average, the highest league average in one league as of December 1<sup>st</sup> for at least 21 games shall be used.

If an entrant has no previous winter average or current league average, the summer league average for at least 21 games as of the previous summer schedule shall be used.

An entrant not meeting one of the above requirements shall be permitted to bowl in the Tournament using her highest current average for at least 12 games as of December 31<sup>st</sup>. All others bowl scratch. Averages from cities outside the Membership of the Greater Mason City USBC Bowling Association shall be accepted. An entrant may participate in Team Events and Doubles, Singles shall be limited to one time.

**Note: Team, Doubles & Singles Event will be Held on both Saturday and Sunday**
